



Welcome to Ashland Public Schools

Age Requirements and Eligibility

For the 2025-2026 school year, children must be five years old by August 31, 2025 to be eligible for Kindergarten, and six years old by August 31, 2025 for first grade. No exceptions to these age requirements can be made.

In Ashland, highly skilled staff ensure that children's first school experiences are positive, nurturing and engaging. Through creative play and peer interaction, children learn vital social and academic skills that will provide the foundation for future success.

Registration Timeline

Kindergarten registration for the fall kicks off in January. Here are some reasons you should enroll your child as early as possible:

- · Help the District plan class sizes for the upcoming school year.
- · Coordinate any services your child may need in advance.
- · Avoid the last-minute summer rush.

^{*} Current Ashland Preschool students do not need to attend this registration event. Preschool students are automatically enrolled in Kindergarten if age eligible. Preschool students will, however, be required to have a screening.

- Student's original birth certificate (with a raised seal)
- Child's current physical and immunization record
 - Must be signed by a physician
 - Must be up-to-date information, even if it will expire before September. You will be asked to update our copy of the medical information after your child's next physical.

Screenings

In addition to completing your child's registration, you will sign up for kindergarten screening. Kindergarten screenings will take place during May. Students who speak languages other than English may also need an English screening at that time.

Required Forms

If you meet our age and residency requirements (or can provide a Residency Affidavit 🔥 or meet the McKinney-Vento eligibility guidelines), you may begin the new student registration process.

Download and complete the registration packet. Save and rename the file with your student's first and last name, then email it to the Central Registrar at registration@ashland.k12.ma.us. Please do not scan or send copies of your birth certificate or any other confidential documents via email.

Why do we screen all incoming kindergarten students?


- Your child visits their new school

Incoming Kindergarten Screening will take place in the Warren School on:

Wednesday, May 28, and Thursday, May 29

You will schedule your time during your registration.



A Kindergarten Teacher's Hopes

Our kindergarten team hopes children will be able to complete the following when they enter Kindergarten... (not all will and we still teach these skills)

Readiness skills:

Follow 2-3 step directions

Be able to pack and unpack (lunchboxes, backpacks)

Be able to open and close containers (water bottles, snack containers, thermoses)

Dress themselves including buttoning and

zipping

Be able to bathroom by themselves including wiping and washing hands

Readiness skills:

- Practice with scissors/cutting
- Have experience playing board games
- (including taking turns, being able to win or lose-good sportsmanship, counting 1:1)
- Practice with turn taking
- Practice with listening
- Be able to share with peers

Readiness skills:

Have experiences with and be able to sit and listen to stories

Recognize letters

Recognize numbers and be able to count up to at least 10

Be able to use manners: please, thank you, excuse me

Practice being patient!

A. Kindergarten EDP is held at the Pittaway School. Attendance is taken at the Warren School at dismissal by an EDP teacher and an aide. The teacher puts the kindergarten students on the bus, and they ride down the hill to the Pittaway School. Another EDP teacher takes them off the bus and takes attendance a second time. EDP for 1st and 2nd graders is held at the Warren School. EDP for grades 3 through 6 is held at the Mindess School. Sixth graders ride the bus over to the Mindess School at dismissal.
